- The application form should reach the Entitlement Unit at least fifteen (15) working days prior to the departure date to allow for processing and postage of the card.
- Applicants with an ID number ending in (A) should include with their application either proof of their National Insurance Contributions or proof that they are married to a Maltese National or a copy of their Certificate of Entitlement.
- Those holding an E106 must acquire their EHIC from the country in which they pay their National Insurance contributions. Those in possession of an E109 or E121 should apply for the EHIC from their country of residence.
- Children under sixteen years of age should be included in the application of one of their parents.
